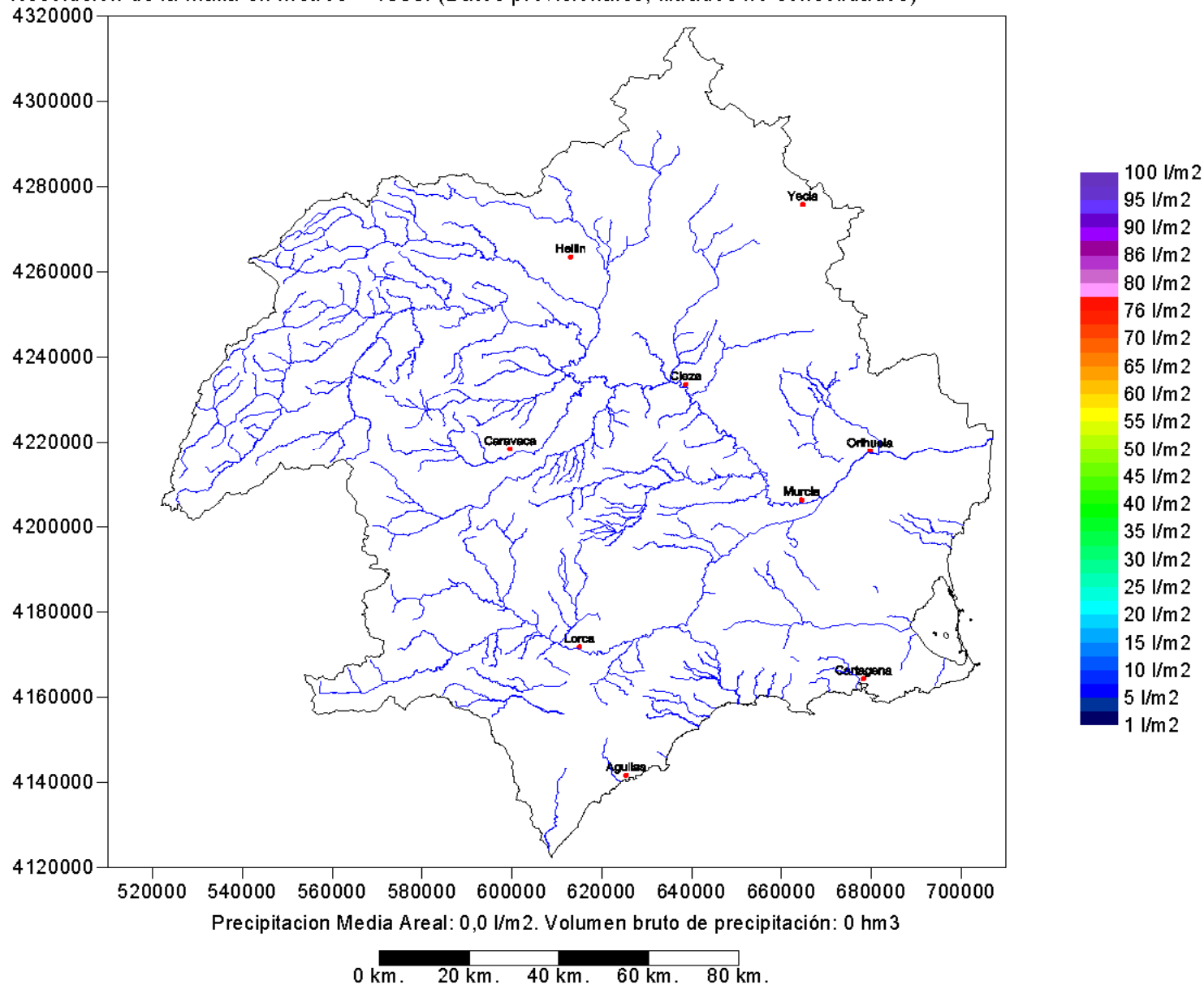


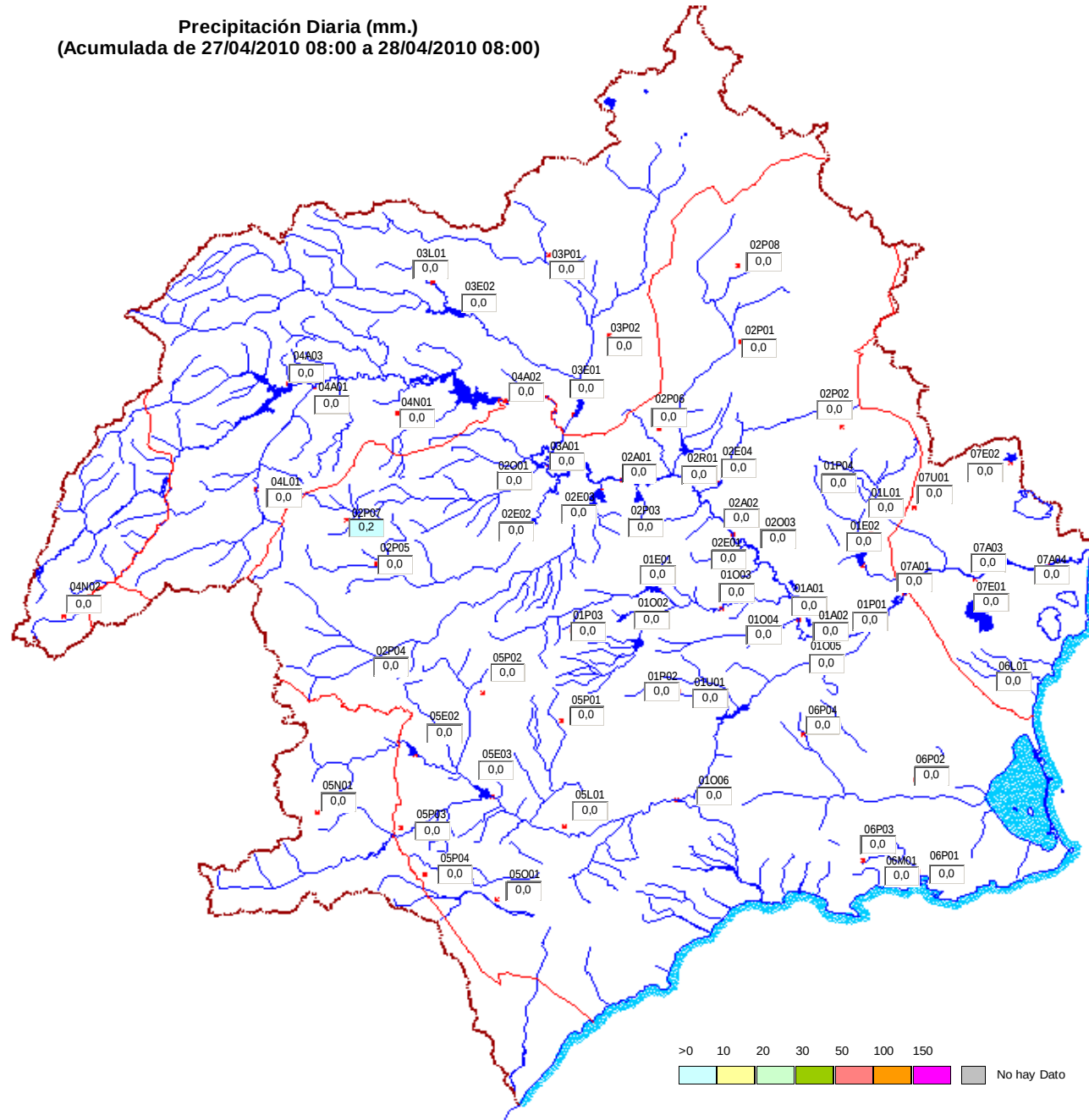
Distribución Espacial de la Precipitación Diaria (mm). (Acumulada de 27/04/2010 08:00 a 28/04/2010 08:00)
