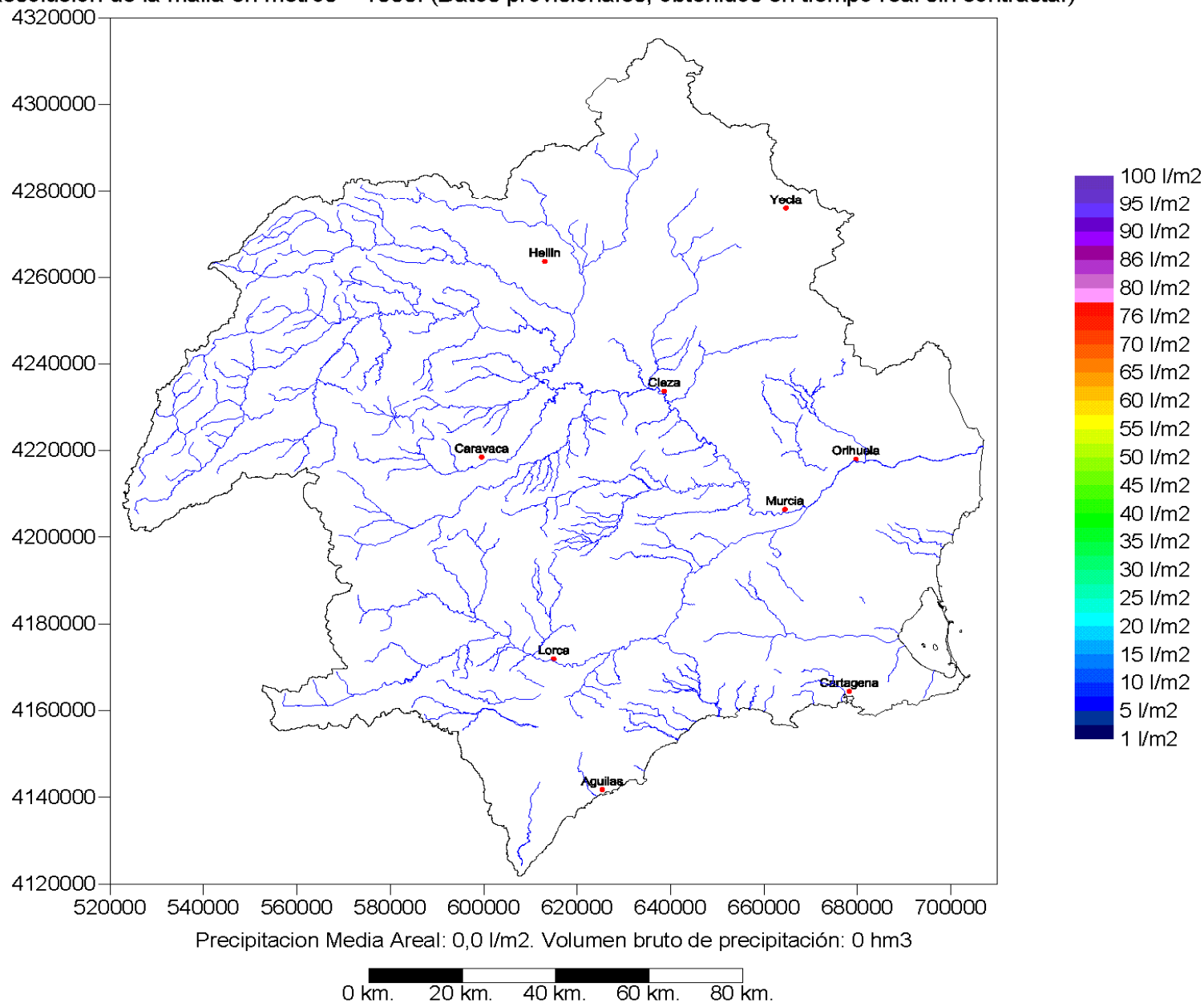


Distribución Espacial de la Precipitación Diaria (mm). (Acumulada de 20/09/2018 08:00 a 21/09/2018 08:00)

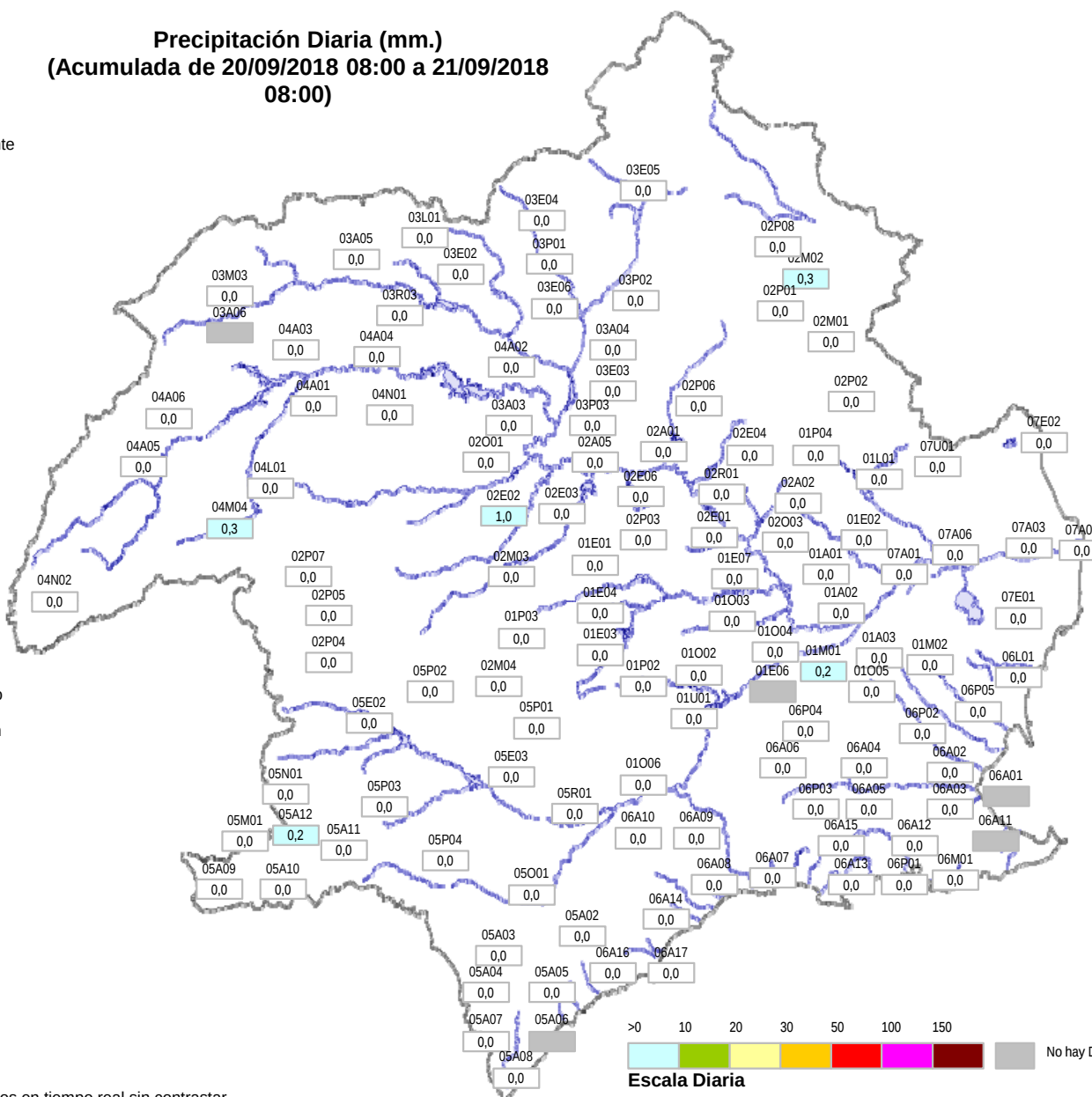
